



## MySTYLONE.COM TERMS OF USE

This document states the terms and conditions governing your use of the MySTYLONE.COM website.

Please read them carefully. These terms and conditions may be updated and amended from time to time, so please visit this page regularly.

By using this site, you signify that you agree with these terms of use. If you do not accept the following terms and conditions, do not use this site.

### 1. ACCEPTANCE OF TERMS OF USE

Welcome to MySTYLONE.com website (hereinafter "the Site"), a service provided by Medelpharm S.A.S. (hereinafter "We", "Our" or "Us").

By visiting the Site, by providing Us with information, by using the services offered by the Site, you agree to be bound by the following terms and conditions ("Terms of Use").

### 2. DESCRIPTION OF SERVICE
